- 3. Limited focus on public health: Private clinics, while providing affordable care, may not address broader public health issues comprehensively. The emphasis on clinical training and revenue generation might divert attention from community outreach programs and address oral health disparities on a larger scale⁸.
- 4. Resource allocation: The resources invested in establishing and maintaining private clinics might be at the expense of other critical areas, such as research facilities, faculty development, or student scholarships. Imbalanced resource allocation can hinder the overall growth and sustainability of the dental college⁹.
- 5. Competition with private practices: The presence of private clinics within dental colleges may create competition with private dental practices in the community. This competition could lead to strained relationships with local practitioners and potentially impact the referral network essential for comprehensive patient care¹⁰.
